## Membership in C.H.I.L.L.D.

C.H.I.L.L.D. is based in Oshkosh, Wisconsin, however we gladly welcome members from the surrounding areas. Regulated (certified, licensed, and provisional) family child care providers are eligible for membership in C.H.I.L.L.D.

Membership is year-round. The membership year begins August 1. New members may join at any time and pay pro-rated dues.

Membership dues are \$20 per year. Dues are used for copying costs, continuing education fees, special activities, and other purposes as determined by the group.

Fees for membership in a professional organization are 100% tax deductible for family child care providers.
